### D. General

We acknowledge that Clearstream Banking's depository will act as tax agent (under the new regime) for ourselves or for the beneficial owner.

We further acknowledge that other parties with whom the beneficial owner is dealing must be informed, in writing, of who will act as the permanent tax representative or tax agent for the Turkish securities held in the Account.

With this request, we include the following documents. For full description please refer to the [Market Taxation Guide - Turkey](#):

- A One-Time Certificate for Turkish Securities, if not already provided; and
- For a foreign non-individual investor:
  - Apostilled Certificate of Incorporation, Articles of Association or Prospectus; and
  - An original, signed and stamped Certificate of Tax Residence (only required if the beneficial owner is claiming DTT relief);
- For a foreign Individual investor:
  - An apostilled copy of the passport; and
  - An apostilled copy of a Certificate of Residence; or
  - An original, signed and stamped Certificate of Tax Residence (only required if the beneficial owner is claiming DTT relief);
- For a Turkish non-individual investor:
  - A Confirmation of the Turkish tax ID number of the institution;
- For a Turkish Individual investor:
  - A copy of an identity card (Turkish resident identity card, driving licence or passport) containing the Turkish resident identity card number (TCKN).

This One-Time Certificate is governed and construed in accordance with the laws of the Grand Duchy of Luxembourg (for Clearstream Banking S.A. customers) and Germany (for Clearstream Banking AG customers using Creation accounts) and the courts of Luxembourg (for Clearstream Banking S.A. customers) and the courts of Germany (for Clearstream Banking AG customers using Creation accounts) shall have exclusive jurisdiction for all legal proceedings relating thereto.
