The undersigned client of Clearstream may hold from time to time, in the Account, securities issued by entities organised under the laws of Hungary (the "Securities").

For the purposes of obtaining a relief from Hungarian withholding tax on dividend payments, we hereby certify that (*tick **one** box only*):

- ☐ We are the beneficial owner of any such Securities we may hold from time to time in the Account and hereby request to register all Securities in our name.

We hereby certify that:

- we qualify as the beneficial owner for tax purposes and are entitled to any related tax relief claimed, based on the applicable tax laws and regulations in the Hungarian market;
- such related tax relief entitlement to any related tax relief is valid for any such Securities sourced in the Hungarian market already held on the Account or to be held in the future in the Account;
- such related tax relief entitlement to any related tax relief is not restricted by any contractual obligation such as a lending or collateral arrangement

We further undertake to provide Clearstream with a new One-Time Certificate and a disclosure of beneficial owners submitted via Swift (formatted MT565) or Xact Web Portal message if, on any record date in Hungary, we hold any such Securities on behalf of a third party beneficial owner.

- ☐ We are not the beneficial owner of all such Securities we may hold from time to time in the Account. We hereby undertake to provide Clearstream with the per-payment instruction submitted via Swift (formatted MT565) or Xact Web Portal message. If applicable, the instruction must include the disclosure of Beneficial Owners, including the names and addresses of the beneficial owner, excluding ourselves, in whose name the Securities should be registered as per each relevant dividend payment date. Any such disclosure of Beneficial Owners shall be valid only for a given dividend payment date and shall not be valid for any subsequent dividend payment date related to the Securities that we might hold in our Account.

In addition to this One-Time Certificate and the disclosure of beneficial owners we will submit to Clearstream the necessary documentation that may be required from time to time.

We understand that, in order to obtain any income payment with respect to the Securities either subject to withholding tax at reduced rate or exempt from withholding tax according to a Double Tax Treaty concluded with the State of Hungary, it may be necessary for Clearstream to supply certain information to Clearstream's depository in Hungary, to the issuer of the Securities and to the Hungarian Tax Authorities. We understand that the Hungarian authorities may forward the information received from us in connection with this procedure to the tax authorities of the countries of residence of the registered owners.

We irrevocably authorise Clearstream to act on the information contained in this One-Time Certificate or in any document submitted to Clearstream pursuant to this certificate. We hereby appoint Clearstream and Clearstream's depository for Hungarian Securities as our attorneys-in-fact with the authority to collect and forward this Certificate or a copy hereof and any document submitted to Clearstream pursuant to this Certificate, as well as the balances of Hungarian Securities in our records, to the competent Hungarian authorities, including the Hungarian tax authorities, in connection with any administrative or legal proceedings or official inquiries to which this Certificate is or would be relevant.

We hereby accept full responsibility in case of any claims or additional taxes, interest thereon, or penalties levied by tax authorities in connection with any payments made in reliance upon this Certificate or upon the list of owners that we have provided and we therefore indemnify Clearstream in respect of any penalties, taxes and interest thereon levied by the Hungarian Tax Authorities or any other authority, and in respect of any other costs incurred in connection with any action taken in reliance upon the contents of this Certificate or other document submitted in relation to this Certificate.

We hereby undertake to notify Clearstream promptly upon receipt of any information that would render any statement in this Certificate or any document submitted in relation to this Certificate untrue or incomplete.

This One-Time Certificate shall be effective as of the date mentioned here below and shall remain valid for 5 years as from that date unless terminated by not less than ten (10) business days' written notice to Clearstream served to the above-mentioned address. Upon expiration of the validity, we undertake to provide Clearstream with a renewed One-Time Certificate.

This OTC is governed and construed in accordance with the laws of the Grand Duchy of Luxembourg (for Clearstream Banking S.A. clients) and Germany (for Clearstream Europe AG clients using Creation accounts) and the courts of Luxembourg (for Clearstream Banking S.A. clients) and the courts of Germany (for Clearstream Europe AG clients using Creation accounts) shall have exclusive jurisdiction for all legal proceedings relating thereto.
