## One-Time Certificate for Turkish Securities

We are aware that tax reclaims cannot be processed through Clearstream.

In order to settle transactions in Turkish securities through Clearstream, we agree to include the trade date, purchase price (except on receive free instructions) and the appropriate Tax ID in our domestic and internal settlement instructions.

We agree irrevocably that we shall indemnify Clearstream for any loss, claim, liability or expense including penalties, tax and interest thereon (and reasonable expenses of counsel) incurred by Clearstream as a result of having relied on this "One-Time Certificate for Turkish Securities" and any other form or documentation provided by us and Clearstream may charge the Account or otherwise reclaim from us and we will pay Clearstream on demand the amount of such charge or loss and any other expenses incurred by Clearstream in pursuing its claim.

We hereby appoint Clearstream and Clearstream's depository for Turkish Securities as our attorneys-in-fact with authority to collect and forward this certificate and any information or documents related hereto to the Turkish authorities or other persons, to the extent required by Turkish law or regulations.

We hereby certify that the above information is true, correct and complete and that we are authorised representative(s) of the client named below.

This One-Time Certificate shall be effective as of the date mentioned here below and shall remain valid for 5 years as from that date unless terminated by not less than ten (10) business days' written notice to Clearstream served to the above-mentioned address. Upon expiration of the validity, we undertake to provide Clearstream with a renewed One-Time Certificate.

This One-Time Certificate is governed and construed in accordance with the laws of the Grand Duchy of Luxembourg (for Clearstream Banking S.A. clients) and Germany (for Clearstream Europe AG clients using Creation accounts) and the courts of Luxembourg (for Clearstream Banking S.A. clients) and the courts of Germany (for Clearstream Europe AG clients using Creation accounts) shall have exclusive jurisdiction for all legal proceedings relating thereto.
