Legal Opinion

For the first NGN issuance for a specific jurisdiction, the issuer, its counsel, the lead manager or the IPA should provide CBL with a copy of the legal opinion obtained by the issuer on the validity and enforceability of securities under:

- The law of the place of incorporation
- The governing law of issuance of the NGN.

The Legal Opinion is only required by the ICSDs once per jurisdiction. The jurisdictions already covered are indicated in the list below. The opinion should be sent at least two business days before the issue date via fax or email to the New Issues Department.
