Introduction

This Cash Timings Matrix is a quick reference guide for settlement currencies eligible in Clearstream Fund Centre Luxembourg (CFCL) via the Creation platform.

Settlement and cash deadlines are aligned with local times such that CFCL takes Daylight Saving Time (DST) changes around the world into account when setting its Central European Time (CET) deadlines. This enables clients to benefit from extended CET deadlines whenever possible. (Unless otherwise indicated, all timings are given in CET).

A new version of this document will be available in October each year.

For more detailed information about the domestic cash and securities services provided by Clearstream Fund Centre, please refer to www.clearstream.com under Products and Services / Market Coverage.

Note: Clients are reminded that CFCL reserves the right to return to the remitter any funds paid to cash accounts not included in this Cash Timings Matrix. CFCL shall not be held liable in any manner whatsoever for any claim arising out of or related to such return.

Cancelling/amending cash instructions

Clients can cancel or amend a cash instruction already sent to CFCL provided that the new instruction is received before the relevant deadline. Instructions that are still in suspense can be cancelled or amended by clients (although pre-advices cannot be cancelled after the earliest deadline for the value date given in the pre-advice of funds instruction).

Instructions are considered by CFCL to be irrevocable and cannot be cancelled once they have been released for settlement in a domestic market or reported in the General Report.

Cash instruction deadlines

Standard deadlines apply to cash instructions submitted via all connectivity media. Cash instruction deadlines vary according to currencies and markets.

Currencies accepted in CFCL are divided into same-day and next-day currencies.

For same-day currencies (VD), the instruction deadline occurs on requested value date and the instruction is eligible for cash settlement for same day value.

For next-day currencies (VD-1 and VD-2), the instruction deadline is before requested value date and the instruction is not eligible for cash settlement for same day value.

The deadlines shown in the Matrix are valid provided that the client's instructions are complete, accurate and eligible for straight-through processing (STP) in CFCL and in the local market. Clients must also ensure that any necessary provision is available. If any of these criteria are not met, CFCL cannot guarantee timely settlement.

The CNH code is commonly used as a reference to the offshore Chinese Renminbi (CNY) in Hong Kong, but is not recognised by ISO.
- f. **HUF**: The deadline for MT103 withdrawal instructions is VD 15:00.
- g. **IDR**: Due to limited market liquidity, withdrawals of IDR with countervalue above IDR 250 billion must be instructed by VD-1 09:00/10:00. Withdrawals instructed for such amounts after the VD-1 09:00/10:00 deadline up until VD 06:00/07:00 will settle with good value on a "best efforts" basis only and may therefore be delayed until the following business day.
- h. IDR: CFCL may be forced to square the FX positions in the domestic market, therefore, the instruction deadline for the case-by-case FX service in IDR is 07:45 CET Winter (VD-1) and 08:45 CET Summer time (VD-1), subject to a threshold limit of IDR 50 billion for Buy instructions. For instructions above this threshold limit or received after the instruction deadline, CFCL will execute the FX operation according to spot market procedures and on a "best efforts" basis. This is a temporarily shortened FX deadline. Please refer to Announcement A23033.
- i. IDR: When instructing for amounts under IDR 100 million, clients must include certain details as indicated in the Market Link Guide.
- j. MXN: Clients must ensure they comply with the local formats as indicated in the Cash services page of the Market Link Guide Mexico.
- k. MYR: For details on restrictions on cash instructions, please refer to Cash payments restrictions on cash instructions in the Cash Services page of the Market Link Guide Malaysia.
- l. MYR: CFCL may be forced to square the FX positions in the domestic market, therefore, the instruction deadline for the case-by-case FX service in MYR is 09:45 CET Winter (VD-1) and 10:45 CET Summer time (VD-1), subject to the threshold limit of MYR 8 million for Buy instructions. For instructions above the threshold limits or received after the instruction deadline, CFCL will execute the FX operation according to spot market procedures and on a "best efforts" basis.
- m. NOK: The IBAN should only be used in field:59: of payment instructions via Swift MT103.
- n. PHP: Pre-advices and withdrawals of PHP must include "REC/RTGS" in the instruction (that is, in field :72: Sender to Receiver Information in Xact via Swift or Xact File Transfer).
- o. **THB**: CFCL may be forced to square the FX positions in the domestic market, therefore, the instruction deadline for the case-by-case FX service in THB is 09:45 CET Winter (VD-1) and 10:45 CET Summer time (VD-1), subject to the threshold limit of THB 30 million for Buy instructions. For instructions above the threshold limits or received after the instruction deadline, CFCL will execute the FX operation according to spot market procedures and on a "best efforts" basis.
- p. TRY: Actual/actual for credit interest, and Actual/360 for debit interest.
- g. **UAH**: Withdrawal of funds is only possible for income and redemption related proceeds. To withdraw other balances originated in UAH you must instruct an FX.
- r. **USD** Citibank N.A.: Only pre-advice is possible.

Pre-Advice instructions

CFCL clients can send a pre-advice providing the CFCL account in tag 25. The CFCL BIC should be used as receiver of the message.

CFCL clients can send a MT103, MT200 or MT202 to their Cash Correspondent Bank to send its cash instruction to CFCL (through CBL CCB's). The MT103, MT200 or MT202 must contain the following:
